

AFFIDAVIT

I, Chad S. Wachter, am employed with Knology, Inc. in an official capacity as the Vice President and General Counsel and do hereby attest to the facts stated herein from my personal knowledge. I hereby swear and affirm that the following statements are true and correct:

1. Knology, Inc. files its application for a state issued certificate of franchise authority on behalf of itself and its subsidiaries, Knology Broadband of Florida, Inc. and Knology of Florida, Inc., hereinafter collectively referred to as "Knology."
2. Knology is fully qualified under the provisions of this Chapter 610, F.S., to file an application and affidavit for a certificate of franchise authority.
3. Knology has filed with the Federal Communications Commission all forms required by that agency in advance of offering cable or video service in the state of Florida.
4. Knology agrees to comply with all applicable federal and state laws and regulations, to the extent such state laws and rules are not in conflict with or superseded by the provision of Chapter 610, F.S., or other applicable state law.
5. Knology agrees to comply with all state laws and rules and municipal and county ordinances and regulation regarding the placement and maintenance of communications facilities in the public right-of-way that are generally applicable to providers of communications services in accordance with s. 337.401, F.S.
6. Knology is seeking a certificate of franchise authority for the following service area, consistent with s. 610.104(2)(e) 5a & b, F.S.;



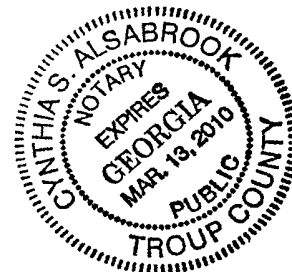
